Only those applications which are forwarded by Ministry of Railways shall be considered by KMRCL.
- 2. All applicants shall apply through proper channel and shall produce a "**No Objection Certificate**" from the present employer at the time of interview.
- 3. APAR's grading for the last five years to be attached.
- 4. Applications received late/incomplete in any matter will not be entertained.
